

# The gap - worldwide

**FIGURE 4.** Global biodiversity conservation financing compared to global biodiversity conservation needs. (US\$ billions)



Note: Using midpoints of the current estimates and future needs, current global biodiversity conservation financing (left graph) may need to increase by a factor of 5–7X to meet the estimated global need for biodiversity conservation (right graph).







# Nature development projects

Budget	€ 2-5 million
Cofin - graad	60% EAFRD 40% Flemish government Sometimes blended with EU (LIFE)
Procedure	Cooperation VLM + ANB
Measures	Working at landscape level <ul style="list-style-type: none"><li>• Restoration of sites / hydrology</li><li>• Legal instruments possible (expropriation)</li><li>• Commission and comité (public bodies and stakeholders)</li></ul>



# Projectsubsidies Natuur

## “Vlaanderens LIFE”

Budget

€ 50K- € 250K

Cofin - graad

50%-90% (50-80% EAFRD)  
Blending is allowed  
You need own co-financing

Procedure

Accessible to all legal entities

- 2 phases (concept note – full proposal)
- 1 oproep/jaar

Maatregelen

- Focus on nature restoration with focus on NCO- wetlands (blue deal)
- Nature management plan = obligatory
- Overhead ok



# Projectsubsidies species

Budget

€ 10K

Cofin - graad

70% (also EAFRD)

Procedure

- 2 fasen indiening
- 1 oproep/jaar

Measures

Implementing species protection  
programmes

- No obligation of a management plan
- Overhead ok (e.g. staff cost)



# Flemish fishery fund

Budget

€ 5K -**€ 50K** - € 6 Million

Cofin - graad

50% - **20%** - 5%

Procedure

Negotiable with fishery  
commission

Measures

Objective: ecological fish stock management

- Recreative infrastructure
- studies
- Measure in or on the banks
- (e.g. fish ladder)



# Afforestation projects

Budget

Limited to € 25K/ha

Cofin - graad

NA

Procedure

Through portal on website

Measures

Afforestation projects (increasing surface area of woodland)

- Endemic species
- Area specific



# Flanders

- Subsidies and funding in place
- Very little private funding
- High demand for funding (more projects applied then can be funded)



## Hedge and tree planting campaign

- Targeted public :
  - Every owner (public or private)
- Co-financing rate :
  - Flat rate depending of the type of plantation
- Deadline : none



# Yes we plant

- Orchards
- Tree lines and pollarded trees



# Arrêt du régent

Creation and development of green areas in urban zone

- Targeted public :
  - Municipalities
- Co-financing rate :
  - 65 %
  - Indicative value : 300 000 to 500 000 €/project

  - No funding limit





## **Bridge Financing & Loans**

- Philanthropic
  - External Revolving Loan Funds
  - Internal Land Trust Protection Funds
  - Foundations (incl. PRIs)
  - Conservation Lenders & Guarantors
- Private
  - Commercial & Farm Credit Lending
  - Seller Financing
- Public
  - Fed/State Revolving Loan Funds
  - Tax-Exempt Debt

# Biodiversity off setting

- Compensate loss of biodiversity
- Net restoration
- Internalize the costs of biodiversity impact as those costs are otherwise borne by nature and society
- First step: avoiding impact, offsetting = last step



# Habitat banking – investing in nature

What if a company wants to invest in nature?

Selling and restoring the land → conservation benefit

Later on selling it to an NGO or public body

Revenue / profit with carbon credits?
